Course Description: This course will apply teaching and learning theory to curriculum development. Creation of curriculum components, evidence-based teaching practices, student outcomes, and continuous curriculum improvement that is aligned with state and national standards will be explored.

Prerequisites: Admission to Education Certificate program or enrolled in the PhD in Nursing program.

Student Learning Outcomes:

Upon successful completion of this course, the student will be able to:

1. Analyze and apply foundational principles, models, and frameworks of curriculum development in nursing education, including backward design and constructivist approaches.
2. Create a comprehensive nursing curriculum that aligns with program outcomes, competencies, and accreditation standards, ensuring the integration of theoretical knowledge and clinical practice.
3. Identify and assess the learning needs of diverse nursing student populations to inform curriculum development, ensuring the curriculum meets the academic and professional development needs of students.

4. Incorporate current research and evidence-based practices into curriculum design to ensure that the content is both relevant and reflective of best practices in nursing education.
5. Integrate essential nursing competencies, including clinical judgement, communication, and professional ethics, into the curriculum to prepare students for practice in dynamic healthcare settings.
6. Formulate clear, measurable, and achievable course objectives and learning outcomes that are aligned with the overall curriculum goals and nursing practice standards.
7. Apply various teaching and learning strategies and educational technologies to enhance student engagement and achievement of curriculum outcomes.
8. Analyze strategies for continuous curriculum evaluation and improvement to ensure the curriculum remains relevant and effective.
