Class Time: Online

Course Description: This course explores the principles and practices of effective project management through weekly readings, quizzes, and a semester-long student-led mock project. Students apply tools and techniques through Gate Reviews aligned with the full project life cycle: from concept to launch and post-implementation review.

This course is a prerequisite for TECH 5334 Project Management Certification. Course content is aligned to PMBOK 8 and includes PMP exam-format scenario questions throughout each chapter to build the judgment skills the PMP exam tests.

Project Selection Guidelines:

Each student will manage an individual project. You're encouraged to choose a project you've worked on in the past, are involved in now, or plan to pursue in the future. It can come from any field — business, construction, software, process improvement, event planning, healthcare, and more.

The key is to lead your project using standard project management practices and tools. You'll learn and apply these methods throughout the course. Your project will move through six formal Gate Reviews (Gate 0 through Gate 5), with each one building on the last. Gate 5 is structured as a projected post-implementation review since the course calendar does not extend into the operational period.

Student Example Submissions:

To help you understand what's expected, you'll have access to several example submissions for each Gate Review. These examples are drawn from past students and are provided to help guide the structure, content, and depth of your own work. Use them as inspiration, not for copying. Be sure to apply your own project context, analysis, and insights. These examples support your success with integrity and confidence.

Goals/Rationale of the Course:

The purpose of this course is to prepare students to manage projects in a wide range of industries by developing essential project management knowledge, skills, and tools. Students will gain experience initiating, planning, executing, monitoring, and closing projects. Through an applied approach using the gate review framework, students will enhance their ability to lead, communicate, and make decisions in complex project environments.

Note from the Instructor:

I know not everyone starts this course as a project management expert, and that is completely okay. The goal is to give you hands-on experience leading a project from beginning to end through six formal gate reviews. You will apply tools and concepts as you move through each gate, and you will receive specific feedback at each stage that should be carried forward into the next.

In real-world settings, project managers are not expected to know everything from the start. They are expected to lead, solve problems, govern decisions, and use resources effectively. That means doing research, checking industry standards, and using tools such as academic journals, professional publications, videos, and AI-based platforms. These tools are part of how modern professionals work every day.

Use these resources wisely, not to avoid the learning process, but to deepen your understanding. Your work should reflect your own thinking, analysis, and application of course concepts. If you reference outside sources, including AI tools, cite them properly. Academic integrity matters.

This course gives you the opportunity to develop your project management skills with confidence, curiosity, and resourcefulness. That is what real-world project leadership looks like, and it is what TECH 5334, Project Management Certification, will build on after you complete this course. Your perspective and creative problem-solving will set your work apart and help prepare you for the challenges ahead.

Course Outcomes/Objectives:

Upon completion of this course, students will be able to:

- Lead a project through six formal gate reviews (Gate 0 through Gate 5), producing the deliverables, governance structures, and evidence required at each gate.
- Apply the PMBOK 8 framework — six principles and seven performance domains — alongside standard project management tools (WBS, CPM, EVM, risk register, RACI).
- Build governance structures that function, including RAPID decision matrices that name accountable individuals, not just roles.
- Distinguish between deliverable completion and benefits realization, and apply post-implementation review discipline to validate whether projects deliver promised value.
- Recognize and prevent common project failure patterns, including governance breakdown, scope creep, requirements without acceptance criteria, and the "we thought we were ready" execution failure.
- Make decisions under incomplete information, with appropriate escalation, documentation, and accountability.
- Build the project management foundation required for TECH 5334 Project Management Certification, including PMBOK 8 framework knowledge and exposure to PMP exam-format scenario questions throughout the course.

Note on quizzes: Six weekly quizzes (40 pts each, 240 pts total) cover chapters from Applied Project Management. Quiz items are course-authored and graded for content mastery. Each chapter also includes seven scenario-based practice questions in PMP exam format, which students are encouraged to use as preparation for the PMP certification, should they choose to pursue it.

Course Specific AI Use

AI tools are part of how project managers work today, and you are encouraged to use them in this course as you would in a professional setting. Use AI to research industry practices, draft initial outlines, polish writing, brainstorm risks, or explore alternative approaches. These uses can make you more effective.

However, you are responsible for the substance of every submission. AI tools cannot complete the gate reviews for you because they do not know your specific project, prior gate scores, or the feedback you receive in this course. Submissions that appear primarily AI generated, such as generic content with little connection to your project, your decisions, or prior feedback, will score poorly regardless of writing quality.

If you use AI tools at any point in your work, cite them in your references list according to The University of Texas at Tyler AI policy. An acceptable citation includes the tool name, version if known, date of use, and a brief description of how it was used. Example: ChatGPT 4.5, October 2026, used to brainstorm risk register categories.

Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the Dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade *only when all of the following conditions are met*: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious

grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. The Grade Appeal form is found in the [Registrar's Form Library](#).

NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
