Welcome to CHEN 4310 – Separation Processes. This course will discuss separation techniques that are used in the chemical industry for isolating components in mixtures, which have economical and environmental implications. We will use concepts of mass transfer and equilibrium to analyze some of the most common separation methods: distillation, absorption, stripping, and extraction. Students successfully completing the course will be able to design multiple cascade units and analyze process performance for a variety of separators in the chemical industry.

CHEN 4310 Separations Course Objectives:

- 1. Explain motivation and techniques for separation in the chemical industry
- 2. Describe and design absorbers and stripping units
- 3. Describe and design porous and non-porous membrane separations
- 4. Describe and design different types of distillation columns
- 5. Describe and design extraction processes
- 6. Describe and design adsorption and ion exchange systems
- 1. The course has three prerequisites which must be completed successfully prior to taking this course:
 - ✓ CHEN 3302 (Chemical Engineering Thermodynamics II)
 - ✓ CHEN 3320 (Mass Transfer)
 - ✓ MENG 3316 (Heat Transfer)
- 2. The goal of our faculty is to be commonly available to you for assistance, so you are encouraged and expected to seek additional instruction (AI). Take advantage of AI, it's FREE and really will help! There are several ways you can seek AI:
 - ✓ You are welcome to stop by the instructor's office at any time. However, for your own satisfaction, you can ensure the instructor is available at the office by using the following options:
 - ✓ Come to office hours (immediately after the lecture period). This is the time the instructor has set aside to answer your questions;
 - ✓ E-mail or call the instructor to set up a mutually agreeable time to meet with the instructor
 - ✓ E-mail your questions to the instructor (this is the least preferred option because of the limited effectiveness of e-mail communication), but it is acceptable if other options are not possible.

3. Classroom Procedures:

- a. Bring study notes, **textbooks**, note-taking material, and calculator to every class. You may not borrow or exchange calculators during graded events. If your calculator fails during a graded exercise, I am not responsible to furnish a substitute. Class preparation is your individual responsibility.

4. Evaluations:

- a. *ACADEMIC DISHONESTY:* Representation of other's work as your own will not be tolerated. Cheating on examinations, quizzes, and homework and the false representation of work will be interpreted as academic dishonesty. Academic dishonesty will be subject to disciplinary action as outlined by the UT Tyler Student Guide on Conduct and Discipline.
- b. *Homework:* Homework problems will be assigned for each module (there will be five homework assignments during the semester). All homework is mandatory and becomes part of your grade. As an engineer your goal is to make a clear, logical, and professional presentation of your work, which is both accurate and correct. As such, both the presentation and the accuracy of your work is important, and both will be graded. It is critical that you show all of your work and leave "footprints" so that it can be easily followed. No guess work should be required to see what you did. For each homework problem, the corresponding topic and numerical answers will be provided. You are encouraged to work in groups, but the work that you turn in should be your own. Homework is *due* at the beginning of class.
- c. Recitations: Towards the end of each module, before the module exam, a lecture deemed "recitation" will be used to review the topic and prepare for the module exam by solving specific problems in class. These will be the students' opportunity to practice problem-solving skills applying the concepts learned in lectures and these special problems will be turned in by the end of the recitation. Please bring your textbook for the recitation sessions. You are encouraged to work in groups, but the work that you turn in should be your own.
- d. Late Submissions: It is a basic principle of professionalism that "Professionals are not late." A "CO-ORDINATED LATE" submission occurs when you will miss the due date for a graded assignment, and you contact me in advance. Notification immediately before the submission will not suffice. Point cuts up to the amounts below may be assessed for a "COORDINATED LATE" submission:
 - 0-48 hours late Deduction of 50% of the earned grade
 - > 48 hours late No credit

Obviously, there are circumstances that will occur and make a timely submission impossible, and I will work with you when and if they occur.

All forms of evaluation in this course must be properly documented. As you are having your work reviewed, it is likely that you might receive help from your classmates, just simply document it. Information from the course textbooks (equations and outlines of procedures), class notes, or me is considered immediately available to all students and need not be acknowledged or documented with one exception. YOU ARE REQUIRED TO ACKNOWLEDGE AND DOCUMENT ALL OTHER ASSISTANCE AND REFERENCES USED. Documentation will be accomplished in accordance with any manual for writing, footnote or endnote, for papers, but for written homework, just place the documentation right at the point you received help using "Who and what" assistance.

- e. *Participation grade*: Students are expected to be engaged in class and outside of the class. The instructor will assign a participation grade to each student based on the following observations:
 - Attendance in class and punctuality;
 - Level of participation in class, asking questions about the material and answering questions from the instructor;
 - Engagement in recitation sessions, demonstrating initiative to work on problems, and actively participating in the discussions;
 - Asking questions outside class: after class, during office hours, and by e-mail.

Attendance in class is the component with more weight on participation. A student that attends every class, but otherwise is not active will receive a 3.0/5.0 as participation grade.

f. Module Exams and Final Exam:

There will be five module exams and one final exam. The module exams will be fifty-five minutes long, and the final exam will be two hours long. The dates for exams are included in the course schedule. Official reasons for missing an exam are outlined in the "Student Handbook". Report any conflict to me as soon as possible prior to missing a module exam. You are required to take a makeup exam, regardless of your reason for missing the scheduled exam. The final exam will NOT be comprehensive. The final exam will cover the module where the most weaknesses have been demonstrated in module exams. You can use a **TI-30 calculator** (or FE equivalent), and *an equation sheet will be provided by the instructor*.

5. Grading:

Grades will be based entirely on the student's demonstrated ability to develop detailed, neat, organized, and correct solutions to the problems presented. Correct answers accompanied by incorrect, incomplete, or untidy solutions may receive no credit.

The class schedule will include assigned reading for every lecture. Students who read the corresponding sections of the book *before each class* will certainly make the most of the lectures, so this is highly recommended. In addition, the instructor will periodically post the lecture notes on the course website. Doing the assigned reading prior to class will help you to understand the material presented during the instruction and will fill in gaps for things we do not cover (*I will not cover everything*). It will also make you more familiar with terms and concepts to be covered.
