Course Objective	<ul> <li>Welcome to CENG 5353 (Operations Research and Advanced Mathematics). During the upcoming semester, I believe you will find our study of Operations Research and Advanced Mathematics to be interesting, challenging, and rewarding.</li> <li>In this course we will learn the state-of-art operations research techniques and advanced mathematics for the analysis of engineering systems. You will be studying on the principles of problem identification and model formulation, linear programming, machine learning techniques, network modeling, probability, decision analysis, and queueing systems. In addition, you will be given the opportunity to apply the principles learned throughout this course and we will work to maximize the use of your computer in support of our work.</li> </ul>

At any time during the exam, your calculator is subject to a random search by the instructor. Failure or refusal to clear all memory or to surrender your calculator to search will disqualify you from the exam immediately, unless you can produce a calculator meeting the requirements as stated above. Design Project	A project will be given, where each student will choose a topic. purpose of this is to train students to learn a relatively advanced topic his/her own, and to teach fellow classmates.					
	The students must submit a paper in the form of a journal paper (introduction, literature review, methodology, data, results, discussion, conclusion). In addition, the students must present their work in the form of a poster at the UT Tyler Lyceum.					
Homework	About 40 homework problems will be assigned out of the textbook. The homework problems will be assigned at the completion of a topic and will be due in class on the day stated in the course schedule. <b>Homework will be uploaded to Canvas as a single Word document (.doc or docx) or PDF.</b> All homework solutions <b>must</b> be submitted on engineering paper (you can buy them in the Civil Engineering Department Office for \$5.00, at Office Depot, or online), stapled at the top-left corner. Homework solutions not submitted on engineering paper will received only 90% of the graded credit.					
	In all your homework and exam solutions, you are expected to present, in written form, the formulae used, the variable values, intermediate calculations, final answers, and their units. Draw a box around your final answer. Not having any of the above will lead to points being deducted.					
	Do not expect all the homework problems be similar to the examples covered during class time. In some cases, you are expected to read additional examples in the textbook or think of the solution yourself or discuss with your classmates.
