Course Description: This upper-level course in communication will examine the interplay between popular culture and the mass media. Through theoretical and practical application, we will explore not only the effect of the mass media on popular culture (and vice versa) but we will also look at how these phenomena affect our everyday interactions with others, ourselves, and our environments.

Student Learning Objectives:

- 1) Comprehend historical and theoretical principles of mass communication and popular culture.
- 2) Identify historical and contemporary sources of popular culture.
- 3) Apply communication theories to various topics and phenomena in popular culture.
- 4) Conceptualize, research, and report original work in oral and written formats for both popular press and scholar audiences.

Course Policies & Expectations

Description of Instructional Methods: While there will be lectures interspersed throughout the class, we will primarily be engaging in active learning through discussion, content creation and curation, presentations, and other independent and group activities. The class sessions, and the corresponding assignments, are designed to provide you with both theoretical knowledge and real-world experience.

Communication: Communication: The best way to reach me will be via email. You will receive group updates from me through Canvas – because that is the system that is available to us – *but do not send messages through Canvas messenger*. During the work week (M-F 9:00am – 5:00pm), I will respond to emails within 48 hours. If you do not receive a response from me within this time frame, please send another message. Response times are subject to delay on the weekends and evenings.

Attendance/Participation: Attendance in class is mandatory. We only meet 14 times total over the course of the semester. If you plan to miss more than one course period you should consider dropping the course. That said, you can have one freebie for the course. If we achieve perfect attendance as a class for the semester, I will jump in Harvey Lake.

Late Work & Make-up Assignments: As a rule of thumb, I do not accept late work. Outside of academia, you will be expected to complete your assigned work by the date it is required. Period. This class will mirror that expectation. Of course, I do understand that life happens. If something comes up, please contact *me prior to the assignment deadline* to discuss your options. Late work and make-up assignments will be assessed on a case-by-case basis.

Technology Use: During each class period we will be doing a variety of activities that will require you to use a laptop or tablet (NOT only bring your phone) to research, write, and present on a variety of topics related to popular culture and mass media. Though we will be using our technology regularly, it should be used for purposes related to the course. Egregious use of technology for alternative purposes – (i.e. Netflix, text messaging, doom scrolling, etc.) will be dealt with on a case-by-case basis.

Classroom Etiquette: Our discussions and class activities will bring us to some topics that may be controversial, uncomfortable, and/or difficult to discuss. It is my expectation that each of you be cordial and conscientious of your classmates throughout the semester. Any inappropriate and/or malicious behavior towards your classmates will not be tolerated. Disciplinary issues will be dealt with on a case-by-case basis.

Grade Replacement/Forgiveness and Census Date Policies:

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated (September 3, 2021). Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date (September 3, 2021) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date).
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade).
- Being reinstated or re-enrolled in classes after being dropped for non-payment.
- Completing the process for tuition exemptions or waivers through Financial Aid

Final Exam Policy:

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members are required to maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy:

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in lieu of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is

unable to complete all course work or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor; and (c) the student presents these reasons prior to the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average for a student.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to complete all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has not been assigned within one year, then the Incomplete will be changed to an F, or to NC if the course was originally taken under the CR/NC grading basis.

Grade Appeal Policy:

UT Tyler's Grade Appeal policy requires the completion of a Grade Appeal form for this action to take place. The grade appeal begins with the instructor of your course. If you do not agree with the decision of the instructor, you may then move your appeal to the department chair/school director for that course. If you are still dissatisfied with the decision of the chair/director, you may move the appeal to the Dean of the College offering that course who has the final decision. Grade appeals must be initiated within sixty (60) days from the date of receiving the final course grade. The Grade Appeal form is found on the Registrar's Form Library.

Withdrawing from Class:

Students you are allowed to withdraw (Links to an external site.) (drop) from this course through the University's Withdrawal Portal (Links to an external site.). Texas law prohibits students who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at other 2-year or 4-year Texas public colleges and universities. Make sure to consider the impact withdrawing from this class has on your academic progress as well as the financial implications.

Brief Description of Assignments

Reading Preparation (300 points – 10 x 30pts/ea): In order to be successful in this course it will be integral to come to class prepared for discussion and engagement. As such, you will need to complete a reading preparation document prior to each class meeting. The preparation document will include discussion, questions, quotations, and short summaries. Your reading preparation document will only be graded if you are in attendance during the corresponding class session.

Class Blog (300 pts): Throughout the course, we will create a public blog about popular culture and the mass media. As a class, in small groups, and individually you will write and edit articles, practice web design, manage social media presence, etc. for the blog. Detailed description in assignment sheet.

Exams (200 points -2×100 pts/ea): In order to ascertain comprehension, you will take two exams over the course of the semester. Each exam will be open-book, untimed, and take-home format.

Term Project (200pts): You will complete a final project that represents a substantial intervention in the study of popular culture and the mass media. Detailed description in assignment sheet.
