SPECIAL NOTE: This syllabus has been constructed on the premise that we will be able to complete the course as scheduled in a hybrid format with face-to-face class sessions on Mondays and Wednesdays, and online (via Zoom) class sessions on Fridays. The syllabus and all assignment requirements within it are subject to change, particularly if public health conditions necessitate converting the course to online-only at some point during the semester.

I. COURSE DESCRIPTION:

A. An exploration into the theory and practice of communication across specialized contexts sports professionals face and the development of journalistic and strategic communication skills needed to succeed in them, including areas such as the press conference, sports feature content, and sports reporting.

V. ASSIGNMENTS

A. (15%) Topic Analysis Short Papers (3): Approximately once per month, you will produce a topic analysis paper (4-5 pgs., double-spaced) on a topic of your choosing from among those we have discussed in class. Personal experiences of sport-related topics are welcome within the paper, but please provide an analysis of the experience that clearly ties to issues and concepts we have discussed. I strongly encourage you to draw upon published works with proper citation (APA style

- preferred), not just our course textbook but other relevant texts. Papers will be evaluated based on content, grammar, and structure.
- B. (20%) Sports event game story (various due dates): Due to the postponement of fall sports at UT Tyler because of the COVID-19 pandemic, I will locate video archives of sports event, which you will use to produce a game story in a style you would see on a digital or print news product (we will discuss elements of sports reporting in class). Alternatively, you may, with prior approval from me, cover a live high school or other college sports contest (you will need to contact in advance the proper administrator for a press pass into the event, and please observe all safety precautions in place). In either case, you will notify me upon the completion of the event (or your viewing of an archived event), from which time you will have 24 hours to produce and submit a 500-750 game story. Work will be evaluated based on quality of content, story structure, and proper grammar and punctuation.
- C. (20%) Audio podcast feature interview (Due Oct. 2): This interview-based assignment will have you focus on a current UT Tyler student-athlete of your choice. You will produce of 3-5-minute audio spotlight which will be graded on knowledge of the subject, narrative building with identification of your athlete's main theme and supporting details, expression and organization of ideas. You will also be accessed on strong storytelling content, your delivery and elements of the production of the audio.
- D. (20%) Press conference (Due dates TBA): In all likelihood, this assignment will involve a mock press conference I will set up with a UT Tyler athlete on a specific class meeting date. The assignment consists of three parts: First, a short advance press release announcing the press conference and providing relevant background information, plus a set of five (5) well-developed questions you would like to ask at the press conference; second, activity and participation in the press conference itself; and, third, a follow-up press release (250-300 words) highlighting the content from the press conference.
- E. (25%) Final exam (Due Dec. 9, 2:30 p.m.): The final exam will be administered through Canvas and cover materials discussed in class, readings from throughout the semester, and terms and concepts from your media production assignments. You may take the final exam between 8 a.m. Tuesday, Dec. 8, and 12:30 p.m. Wednesday, Dec. 9. You will have a two-hour time limit for the exam, making the latest possible submission time to be 2:30 p.m. on Wednesday, Dec. 9.

VI. ALL ASSIGNMENTS ARE UPLOADED TO CANVAS.

A. Your analysis papers and other assignments will be submitted to Canvas. Deadlines are vital elements in every form of sports communication and cannot be missed. A missed deadline will result in a 15% deduction per day.

VII. Policies

A. Course Withdrawal: The last date to withdraw from classes is November 2, 2020.

- B. Final Examination Due Date: Wednesday, December 9, 2020, 2:30 p.m.
- C. **Electronic Devices:** Turn off all electronic devices including cell phones and MP3 players. Allowing a cell phone or other device to ring during class is rude and disrupts class. No text messaging or checking the time on your cell phone during class. Keep these devices in your backpack during class.
- D. **Use of Computers in Class:** Do not use computers during class for reading/writing email, surfing the Web, playing games, working on assignments for other classes, or writing letters. You may use a laptop computer only for taking class notes. If you use your laptop for any other purpose, I will require you to immediately close the computer.

E. Assignment Policy:

- 1. Assignments will be given throughout the semester. Students are responsible for all course materials, including, but not limited to, class lectures, handouts, workbook and textbook reading assignments.
- 2. Assignments and due dates may be changed at the instructor's discretion with fair notice to students.
- 3. Students must complete all assignments in order to pass the course. This does not mean that merely completing all assignments guarantees the student will pass the course.
- 4. Unless otherwise specified, assignments are due at the beginning of class.
- 5. All papers must be typed or word-processed using the format required for the assignment.
- 6. Spelling, grammar, and structure are as important as the content of any written work.
- F. Late Assignments: Late assignments are discouraged and will be assessed a penalty prior to evaluation. Assignments are due at the beginning of the class period on the date specified.
- G. Attendance and Tardiness Policy: Students are expected to attend class. If you must miss a class session due to an illness (doctor or health clinic note required), funeral of an immediate family member (copy of obituary or service program required), or university-sponsored activity, please contact me as soon as possible to inform me of your expected absence.

Five or more absences from class, unless resulting from a prolonged illness that requires the student to remain at home, will result in the deduction of one letter grade from the final course grade. H. Grade Replacement/Forgiveness and Census Date Policies:

- 1. Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (STE 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is September 9, 2019.) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.
- 2. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.
- 3. The **Census Date (September 9, 2019)** is the deadline for many forms and enrollment actions of which students need to be aware. These include:
 - Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
 - b) Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
 - c) Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
 - d) Being reinstated or re-enrolled in classes after being dropped for nonpayment
 - e) Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy:

- Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
