**Course Description:** This course will cover the techniques used to secure and manage computers, computer networks and enterprise computer systems. Topics covered will include security policies, computer network management, and disaster recovery. Special emphasis will be given to designing, deploying, and managing complete security systems.

#### **EXPECTATIONS OF STUDENTS:**

- Be prepared for lectures and take notes. I expect you to have read the assigned readings. Class time is primarily for extending and applying what you learn from the readings. If you come unprepared, you will get significantly less out of class and guickly fall behind. Be an active note-taker.
- Attend the lectures and be on time. There will be times when you will want to skip class. Make your
  education a priority. During the lectures, I will reinforce material from the textbook and cover things that
  are not in the textbook. You will still be responsible for this material. Missing a lecture should be a rare
  occurrence. If you do miss the lecture, get the notes from another student. See me during my office
  hours for clarification of any missed material.
- Take ownership of your learning. You are solely responsible for how much you get out of this course. It is not my responsibility to spoon-feed you knowledge, but rather to guide you along your developmental path. I hope that this course will challenge you. Deep learning happens when you struggle and succeed. During lectures, your participation and undivided attention are critical. On the assignments, leaning too much on looking at someone else's code robs you of learning and tricks you into thinking you understand more that you do.
- Seek my help early if you feel lost. If you are doing the readings, attending the lectures and taking copious notes, and yet you still feel lost, do not convince yourself that things will get better on their own or that you will catch up this weekend. This course, like most others, builds on itself throughout the semester. Come see me before the feelings of confusion compound.

  unadministered test, test key, homework solution, or computer program or information about an
  unadministered test, test key, home solution or computer program;
- falsifying any academic work offered for credit;

  gained by such conduct; and

Grade Replacement/Forgiveness and Census Date Policies – Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy – Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
