- Provide conduct statistics




### **Academic Misconduct**

 I typically see 50 - 60 cases or so per year. There is <u>no</u> <u>way</u> that they are the only ones that happen

**2**018 – 19: 54

**2019 – 20: 59** 

■ 2020 - 21: 88 (YTD)





### **Academic Misconduct**

- Many cases involve plagiarism
  - Many of these appear to be cases of students not knowing how to cite properly
- More and more are cases involving online resources like Chegg and Course Hero
- Most academic misconduct cases are handled at the faculty level



## **Typical Academic Sanctions**

- Warning
- Re-submit assignment (possibly for reduced credit)
- Failing or reduced grade for assignment
  - Most common outcome,  $\sim$ 2/3 of the cases
- Failing or reduced grade for course
  - $2^{nd}$  most common outcome,  $\sim 1/3$  of the cases




### **Previous Years in Conduct ...**

- Average number of individual students charged through the code WAS about 100 per year through about 2012 or so.
- '15 '16 was our busiest year, with 481 students
- '18 '19, we had between 483 and 500, so we'll likely stay in this range
- Data for last year indicates roughly the same pattern
- We've had 330 so far this year

### **Previous Years in Conduct ....**

- What policies are violated most often?
  - Alcohol
  - Drugs
  - Academic misconduct
  - Noise (housing)
  - Harassment



### Title IX

- Around 40 Title IX reports filed annually
- Can report online or by contacting me, UPD, HR, Dean of Students or Title IX office



# **CARE Team (formerly BIT)**

- The CARE Team (Campus Assessment Response and Evaluation) is made up of at least one staff member from UPD, Conduct, Dean of Students, Counseling, Academic Success, and Residence Life
- Can address behavior that is unusual and/or concerning, and that may or may not appear to be a violation or threat
- 157 CARE reports filed last year involving 171 students of concern – the largest number of intervention cases to date
  - Until now ... 222 students of concern
- Common outcomes: welfare check, referral to Student Services, referral to Conduct



### What's New?

- More CARE cases
  - 222 students of concern this year to date
  - 180 students of concern in 2019 20
  - 171 students of concern in 2018 19
  - 113 students of concern in 2017 18
- Disclosures to Me
  - Last year, I referred 39 students to counseling, Title IX or both
  - This year, I've already had 42



### What's New?

- More academic misconduct
  - **2**018 19: 54
  - **2019 20: 59**
  - 2020 21: 88 (YTD)
- More use of online resources in cheating
  - I cannot do the investigations in most cases, but I have resources to help faculty request data from Chegg
