President's updates:

- New classroom technology staff: coming on board soon (1 additional employee). Plans for another person in the next fiscal year.
- Admissions Standards Adjustment Discussion: All Texas public institutions are required to take the top 10% of students (based on class rank) from each Texas high school. UT-System Rules allow for up to 25% for automatic acceptance (depending on whether the president of each school wants to implement the rule). Currently, UT-Tyler only auto-admits the 10%, which puts us as third-most stringent in the UT system (behind UT-Austin and Dallas). The next step we use in admissions is SAT scores, which means we are missing a lot of local students (our average SAT is 1000, average SAT of Tyler students is 850). That means, a local Tyler student who is in the top 15% of their class, but has a 950 SAT score, probably won't get in here so they will go to another school (SFA, A&M commerce, community

- colleges). This is reducing the # of local, first semester freshmen that we get here. The proposal is to adjust admissions standards, either adjust down SAT, or adjust down class rank, or both.
- Housing study: Housing is currently about at capacity (about 2,000 beds on campus). By 2020, we will probably be over capacity. Hope is to expand housing options by 2021 (by about 400-500 beds) to accommodate the growth in the student body, especially students from outside of the region. Student feedback, wants/needs will be a part of the housing study.

Questions answered by the president:

- <u>Plaza construction update</u>: The front entrance of the UC will be closed temporarily starting Monday 5/20 due to construction. Expected completion date is the end of Summer II/beginning of Fall 2019 Semester.
- <u>Nursing building update</u>- negotiating funding, Tuition Revenue Bonds are a possible mechanism to fund the facility, working on this with the legislature. There remains a request for building funds before the UT System as well.
- Faculty hiring process update: From now on, 100% of searches (faculty and all other types) will go through HR. Current system has the job applicant routed to the department and its search committee. Proposal is to have all new hires go to the UT-Share system on the university website, which will have HR be the repository of all the information and documents. This will make it easier for university to keep track of the hiring process in general, as well as our compliance with federal laws in our hiring practices (equity and diversity in hiring, Title IX, discrimination, etc.).

12:56 **Updates from the Provost's Office** Dr. Amir Mirmiran

- <u>Search Updates</u>: Dean of CEP search is ongoing. 6th and final candidate will be wrapping up on-campus visits next week, hope is that search will be concluded in the next month. A new search for Associate Provost for Research and Scholarship will begin in early June (they wanted to wait to start the search until after the East Texas Research Conference).
- East Texas Research Conference: over 490 attendees from universities and community partners all over the region. Provost suggests that they might want to move the conference up to late March or early April so that more students will be able to attend. Would like to also include a component in the conference that solicits request for ideas, needs, from the community and then have solutions presented at the conference. **Question**: Is there a way to include music and arts more than they were this year? Answer: The intent has always been to include all types of scholarship. Provost clarified the conference is geared towards relevance to East Texas, not necessarily specific disciplines.
- <u>Student Success Showcase</u>: The presentations were successful. Thank you to Dr. Sass for organizing it. They hope to expand it next year.
- <u>Academic Schedule Committee</u>: Dr. Geiger will be chairing a committee to revisit the academic schedule. There are issues related to classroom utilization, inconsistent and offschedule class meeting times. Committee will begin to meet over the summer and will include students as well.

- *QEP* Frank Dykes
 - o SACS accreditation taking place in 2021. Chosen topic is "Solving Real-World, Complex Problems." The concept is how to apply knowledge to real-world problems, as this translate for each specific discipline. Literature review for concept paper is being written this summer. Next year, they will work on marketing and budget for the QEP.

 - Working on committee structure and budget. Dr. Geiger clarified some of the mission and scope of the committee (to offer guidance to programming at the Cowan Center). Dr. Geiger also asked whether this needs to be a university committee, or if the director of the Cowan Center should be in charge of convening the committee.

 - o The Provost is the chair of the HOP committee. Edits and updates are ongoing to get ready for the 2021 SACS visits. Please alert a faculty senator if you find any problems/anomalies in the HOP so that it can get updated. Dr. Geiger- any feedback on the HOP from faculty would be very useful.

1:48 **Diversity and Inclusion Resolution**

John Lamb

- Dr. Lamb (Faculty Advisory Council Representative) presented a draft of a resolution about diversity and inclusion put together by an ad hoc committee.
- The resolution (see attached) has several purposes:
 - O To put forth a Faculty Senate definition of the terms "diversity" and "inclusion." The purpose of the proposed definitions is to build upon and formalize the disparate statements already in existence here at UT-Tyler (HR statement on not discriminating in hiring processes, FLC for Global Awareness and Diversity) and to incorporate examples from other aspirant peer universities. Currently, there is not an official UT-Tyler definition of these terms and/or how they should apply in the university setting.
 - o It resolves that the Senate will create an ad hoc committee to review current university policies and practices related to diversity and inclusion, and look into establishing a Division of Diversity and Inclusion, possibly in Academic Affairs.
- <u>Discussion</u>: Dr. Geiger pointed out that UTT has an EEO statement that lays out groups that cannot be discriminated against, and the proposed list builds on that. He also asked why it the division should be limited to academic affairs. Dr. Geiger also asked that senate checks that there isn't an existing committee as a part of the existing list that doesn't deal with this already (or does HR already deal with these issues). Idea was also posed by Gracy Buentello to add Title IX Coordinator as an involved party in the resolution. Dr. Gary Miller suggested adding a member of athletics to the ad hoc committee as well.
- Motion (F. Dykes, G. Miller) to adopt resolution with an amendment to include other interested parties in the ad hoc committee. Resolution was voted on and adopted (pending the inclusion of votes from absent senators via email)
