Tyler MSA Loses \$220.5 Million, Longview MSA Loses \$168.6 Million to Stay-at-Home Orders

In this special issue of the *Hibbs Brief*, the impacts of limits on economic activity as a part of the effort to slow the spread of COVID-19 are calculated. Both Tyler Metropolitican Statistical Area and Longview MSA suffered nine-figure losses over roughly a one-month period.

As previously discussed, intensified mandatory social distance and a two-week stay-at-home measures were taken by Smith County officials by the end of March.¹ Later, on April 7, County Judge Nathaniel Moran extended the stay-at-home order for all Smith County residents until April 30.² The mandatory stay-at-home order requires all individuals anywhere in Smith County to stay at their houses, except people who conduct certain essential activities, services and work. Similar orders were issued in Gregg County by County Judge Bill Stoudt on March 25.³ Those orders also lasted until April 30.⁴

Given that Smith County officials extended the stay-at-home order to practically include one month since late March to April 30, the *Hibbs Institute* updated their previous estimates to include the new time frame. Gregg County stay-at-home orders covered a similar time frame. These estimates comprise the negative economic impacts of a one-month reduction or cease of nonessential businesses included in the following sectors: *Retail Trade; Food Services; Art, Entertainment and Recreation; and Personal Care Services*.⁵ The economic loss in dollar value for Tyler and Longview MSAs were estimated based on the annual output of each one of the mentioned business sectors and calculated for the mandatory stay-at-home order. These estimates add up to **\$220.5 million** in the Tyler MSA and **\$168.6 million** in the Longview MSA in one month.⁶ Differences between Tyler and Longview impacts are attributable to their share of the examined sectors; a larger economic loss suggests a sector with greater economic activity. The economic impacts by business sector for the two MSAs are detailed in **Table 1**.
