HIST 3497 Topics in History: The Global Great War, 1914-1919 Fall 2022

Course Description:

In 1914 Europe was plunged into its bloodiest war to date. The First World War fundamentally altered the geographical, social, cultural, and military landscape of Europe. Though the war often receives less consideration in the United States, it is integral to understanding the Second World War as well as the latter half of the twentieth century. The Great War set the tone for modern warfare, significantly altering the way people interacted with each other as well as military planning. This course will require a significant amount of reading, writing, and research.



Online Structure:

Lectures will be recorded and posted on Canvas Sunday nights. You can watch them whenever works for you, but you are responsible for watching *all posted content for the week*. This means all posted lectures, any extra videos (films/documentaries), as well as the assigned readings for the week (see class schedule). There may be short readings uploaded for certain modules.

Course Objectives:


By the end of the course, students should be able to do the following:


- analyze significant issues, trends and developments in the era of the Great War
- demonstrate knowledge that history is not simply the recitation of names and dates, but instead is a fluid subject where interpretations are constantly changing as a result of different methodologies and patterns of analysis
- analyze and synthesize sources in order to put forward a well-supported argument of their own

• make a clearly written and clearly-presented argument, including a thesis and sufficient and well-used supporting detail

*Please feel free to use eBooks or audiobooks if those are your preference. I will provide Chicago Manual of Style for both. Regardless of which format you choose; you will need to make sure you still take accurate notes. Any edition is fine (make sure you're purchasing English translations).

Explanation of Assignments:

<u>Weekly Responses</u>: You are required to write **11** weekly responses out of the semester (this means you get 3 freebie weeks).

These responses should be two *full* pages in length and should address the major issues of the week, critically analyze these major issues, and include a discussion of the week's readings. Strong responses will synthesize lecture and the readings. Throughout the semester there will be additional material. These must be included in your weekly response. You **MUST** demonstrate that you have watched *all* the posted videos as well as done the week's readings (this means citing the reading using Chicago Manual of Style aka footnotes).

These are geared to help you prepare your thoughts for discussions and will provide a helpful tool when preparing for the final exam. These are also designed to make sure you're writing every week as this is the best way to improve your writing and analytical skills. **These are due Sundays by 11:59pm to Canvas. No late submissions accepted.**

Essays: You will write two 5-7-page, double spaced essays. One will discuss Ernst Jünger's *Storm of Steel* and Maria Botchkareva's *Yashka: My Life as Peasant, Soldier, and Exile.* The second paper will analyze Martha Hanna's *Your Death Would Be Mine.*

 The prompts for this essay will be posted at least 2 weeks ahead of the deadline.





<u>WWI Film Review</u>: You will write a 4-page, double spaced review of a World War I film. A list of eligible films and documentaries will be posted for you to choose from. If you would like to review a WWI film not on the list, it must be approved by Dr. Link at least 3 weeks before the assignment deadline. The goal of this assignment is to assess the use of history in the film and how they approach the task of balancing factual history with a Hollywood film. More detailed instructions will be uploaded to Canvas prior to the assignment deadline.

<u>Final Exam</u>: There is a take home, essay format final exam covering the entire semester. Instructions for the final exam will be distributed one week prior to the exam due date. Essays will need to synthesize lecture and class readings to demonstrate your mastery of the term's information. This final is cumulative and therefore the responses must reflect the entirety of the semester.

Extra Credit Opportunities: Extra credit may be offered. Any opportunities will be posted on Canvas.

Quizzes: I reserve the right to give short quizzes over the assigned readings or other course material. Each quiz will be multiple choice and will be worth ten points.

THERE WILL BE NO INCOMPLETES for failure to complete an assignment. Assignments not turned in will result in a 0 for that assignment.

Course Etiquette:

- 1. Make sure to have your Canvas notifications sent to your email. You are responsible for staying up to date on deadlines, announcements, etc.
 - a. You are responsible for all class lectures, readings, and any other videos assigned.
- 2. Late assignments lose **10 points** deducted for each day the assignment is late. All assignments are due by the assigned due date on Canvas. Assignments turned in after that will lose points. Weekly responses are the exception and late submissions will not be accepted.
- 3. No emailed assignments-use Canvas.
- 4. The classroom space is for intellectual growth and to achieve that we must all be respectful and courteous to each other. Respect is a must! We will not always all agree (that is the heart of academics!) but it is crucial that we express our ideas in a respectful way. If a student does not adhere to these guidelines, they will receive a 0 on the weekly responses and, upon further infractions, they will be reported to the university and receive a 0 in the course.



- a. <u>Be courteous:</u> Remain patient, ask/wait for clarification, avoid assumptions and rushed judgement. Forgive mistakes and apologize for errors.
- b. <u>Be a good colleague:</u> Remember your role as a student in the course. Make sure you're following directions. Be authentic and collaborative with colleagues. Be aware of your behavior and how others interpret your communication.
- c. <u>Be professional:</u> Proofread your own writing for spelling, grammar, and punctuation to prevent miscommunication. Avoid slang, sarcasm, or emotionally charged writing. Profanity and offensive language will not be tolerated.

Email Policies

As this is an online course, I will check email regularly each day. You may expect a reply within 24 hours during the weekdays (Monday-Friday), and within 36 hours on the weekend (Saturday

and Sunday). If you have a procedural question – about due dates, what the assignment requirements are, etc. – I strenuously encourage you to check the syllabus and the materials on Canvas, as your answer may be there, and you can know immediately, rather than awaiting an email reply.

Finally, even in an online setting, university education occurs in a formal setting. When emailing your professors – me or any other faculty on campus – please greet them properly (e.g., "Dear Dr. Link," "Hi Professor Link," "Good evening, professor," etc.); avoid "Hey," "I have a question," "Can you tell me...?", "Yo holmes," etc. – and yes, I have seen all of these in emails before.] I will always address you directly and respectfully in my individual emails to each of you; I ask the same courtesy in return. If students continue to refuse to address the faculty by name, I reserve the right to not reply to the email. Grade Replacement/Forgiveness and Census Date Policies:

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- · Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- · Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- · Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- · Being reinstated or re-enrolled in classes after being dropped for non-payment
- · Completing the process for tuition exemptions or waivers through Financial Aid State-Mandated Course

Drop Policy:

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
