Course Overview and Course Objectives:

This course is a graduate research seminar designed to formulate professional research and writing skills for academic historians. The ultimate goal is for students to produce a research paper suitable for presentation at an academic conference. Our topic is one of pivotal importance for world history. In our readings and discussions we will examine the career and conquests of Alexander the Great, as told by the surviving Greek and Roman accounts of his life. Further we will explore the foundations of Alexander's monarchy, as established by his father, Philip of Macedonia. Finally, we will also look at the careers of some of Alexander's successors as well as some of his opponents.

Course Requirements and Grading Policy:

The main requirement of the course is the production of a research paper of roughly 12-15 pages on a relevant topic of your choice. It will constitute 70% of the course grade. The remaining 30% of your grade will consist of three short (3-4 page) papers worth 10% each.
