COURSE MEETING DATES

This course meets the second 7-week session of the Fall 2021 semester (October 11 - December 4).

COURSE DESCRIPTION

This course is designed to assist individuals in identifying essential behaviors necessary for optimal well-being, including a health-enhancing lifestyle. Students are presented with evidenced based strategies for improving and maintaining good health. Topics addressed include physical health; emotional health; social health; mental health; diseases and disorders; sexual health; alcohol, tobacco, and other drugs; environmental health and consumerism; and healthy aging and end of life preparation. There are no prerequisites for this course.

REQUIRED MATERIALS

There is no physical textbook to purchase. Instead, you are **REQUIRED** to purchase an online subscription to a tutorial e-textbook <u>through Canvas</u>. A step-by-step guide on purchasing the subscription will be provided in the *Getting Started* module in Canvas (<u>a link to purchase will be provided in the first lesson [Orientation] in Module 1</u>). The online subscription contains your lectures, learning activities, quizzes, and exams. You **MUST** purchase the subscription to access to all the course content. For assistance, or for technical issues, contact Caduceus. <u>Technical requirements</u>: Minimum technological requirements that must be met in order to complete this course can be found in the *UT Tyler Student Resources* link in the *Getting Started* module in Canvas. If you have technical problems in Canvas, please refer those to the UT Tyler Campus Computing Services.

COURSE STRUCTURE

The course is accessed online through *Canvas*. Links to the online e-textbook subscription (*Caduceus*) will be provided here. The course is organized into 12 chapters or lessons, grouped into 7 weekly modules. Each module contains one or two chapters. Within each chapter, you will find learning objectives and activities to complete. Most of the learning activities will be completed in Caduceus (the online e-textbook subscription); however, some activities (discussions, journals) will be completed in Canvas. All activities to be completed are listed in their respective modules. Due dates for all activities are provided in Canvas; in general, all activities are due by 11:59 p.m. (CT) on the Sunday at the end of the module week. Exceptions to this are the final week, in which assignments are due by 11:59 p.m. on Friday.

<u>Caduceus activities:</u> A combination of lectures, flashcards, self-tests, and quizzes will be used to cover course content. Each module in Canvas links to one or two chapters in Caduceus. Each chapter contains several learning activities, including a timed and graded quiz. You should expect to spend approximately 3 to 5 hours on each chapter.

All assignments in Caduceus must be completed in full before you can take the final exam online. All quizzes and exams will be automatically graded and sent to you and your instructor with your completed summary sheet. Therefore, going into the final exam, you will have already completed every other portion of the graded work. You will not be able to open or complete the final exam without the other work being competed.

<u>Canvas activities</u>: Learning activities in Caduceus will be supplemented with module discussions and health journaling in Canvas. Each student will participate in discussions of important concepts in each module and will track changes in health behaviors over the course of the semester. More details about these assignments are provided later in the syllabus.

<u>Course pace</u>: The course is designed to stay on a strict and scheduled pace. Do NOT let yourself fall behind. You may work ahead in the course and finish it much earlier than the end of the semester. In fact, working ahead is encouraged. If you fall behind (I will remind you if I see you are doing so), it will become difficult to catch and keep up.

COURSE OBJECTIVES

Upon successful completion of this course students will be able to:

- 1. Demonstrate knowledge of key components of health including psychosocial, physical, diseases and disorders, substance use & addiction, environmental health, and healthy aging.
- 2. Identify, analyze and evaluate lifestyle behaviors that are positive to health and lifestyle behaviors that are negative to health.
- 3. Discuss the interrelationship of heredity, behavioral and the environmental influences on health.
- 4. Describe symptoms and treatment options for specified diseases, disorders and conditions.
- 5. Critically analyze and evaluate health care, health products and health messages.

*More specific learning outcomes will be provided in each learning module.

COURSE REQUIREMENTS AND EVALUATION

Learning Activities: There are various learning activities in each of the 12 lessons. These consist of recorded lectures, flashcards, ungraded self-test practice quizzes, and additional resources. All learning activities in Caduceus (excluding timed quizzes and exams) are graded on a complete/incomplete basis. Therefore, you must complete all of them to receive credit. There are 62 activities, each worth 0.2 points, for a total of 12.5 points (actually, 12.4, but another 0.1 point is given for completion of your Introduction).

<u>Chapter Quizzes</u>: Each lesson/chapter will contain a 24-question, 12-minute time limit graded quiz over all the material in that particular lesson. Since most modules contain two lessons/chapters, they will have two graded timed quizzes. Each quiz is worth 2.5% of your overall grade for a total of 27.5%.

Exams: The midterm and final exams cover the quizzes, flashcards, and self-tests in Caduceus. Be sure to review your online materials before the exam.

The **midterm exam** can be completed at any time after you have completed the work in Lessons 1 - 6. It has a time limit of 110 minutes and consists of 100 multiple-choice questions from Chapters 1 - 6. The midterm exam is worth 25% of your final grade.

The **final exam** can be completed at any time after you have completed all work in Caduceus and feel prepared for the 150-question exam. The final exam has a 2-hour time limit. The exams are taken online and, during the exam, your e-textbook is locked for security. The final exam is worth 25% of your final grade.

Module Discussions: For most modules, students will participate in a discussion of a topic related to that module. These assignments allow you to demonstrate your comprehension of the course material and your ability to express that comprehension through written and/or oral communication. There are 7 discussion activities throughout the semester; your top 5 scores will be counted at 1 point each for a total of 5 possible points.

Health Behavior Change Journal: During the first week of class, you will start a Health Behavior Change Journal in Canvas, in which you identify a particular behavior you want to change. Throughout the semester, you will will keep track of your progress toward these goal(s) and incorporate the latest lessons into your journal. These journals need to be kept up-to-date throughout the semester and will be checked on a weekly basis. There will be 7 journals checks and your two lowest scores will be dropped.

COURSE POLICIES

<u>*Professionalism*</u>: Students are expected to display a professional attitude in all aspects of the course, including discussions in Canvas and FlipGrid and communication with the instructor and classmates.

<u>Quality of work</u>: All assignments, including exams, presentations, participation, and projects, will be graded with rigor appropriate for upper-level undergraduate course work. All written assignments should incorporate correct grammar, spelling, and a logical flow of ideas. I have little tolerance for bad grammar and spelling mistakes. Please use the Spelling and Grammar tool in your word processing software.

<u>Due dates</u>: Due dates are listed for each assignment. The exam due dates are firm. Be sure to complete the exams by those dates or you will not get credit for them. Generally, all module activities are due by 11:59 p.m. (CT) on Sunday at the end of the week that the module is available (exceptions are the exam due dates). You may work ahead in this course and complete activities and exams before the assigned week. However, the Health Journal will be graded at the end of each week (you can't rush change).

<u>Make-up work</u>: Make-up exams and assignments will be given only according to University policy. On rare occasions (and for a valid reason), make-up exams can be scheduled by pre-arrangement with the instructor *before* the date of the exam. If any exam is missed due to illness, injury, or family emergency, the instructor should be notified prior to or within 24 hours of the missed exam.

<u>Feedback on exams/assignments</u>: I will strive to give timely feedback on all assignments. You should expect feedback on discussion posts within a couple of days and feedback on papers within 1 week (I will notify you if I expect feedback to take a little longer for a particular assessment).

<u>Getting help</u>: If you find yourself struggling in the class (especially if you fail an exam), you should meet with me as soon as possible so that we can determine what steps you need to take to succeed in the class. I'm available during my office hours or by appointment. I also have an open door policy.

TIME REQUIREMENTS

Successful on-line learning is highly student-initiated. Because of the format of the course, the student will be required to exercise initiative and diligence in completing the course. In general, you should expect to spend a similar amount of time completing the requirements of this online course as you would spend on the same course taught in the traditional classroom format. An advantage of the online format is that the lecture material is there for you to review whenever you want. In an online course, more time must be devoted to participation in discussions than is traditionally spent in classroom discussions. Time for completion of assignments, readings and other materials, reviewing for comprehension, and preparing for exams should be similar in this online course as in any other course. As a guide, you should plan to spend approximately 10-15 hours per week on this course in a traditional 15-week semester (adjust your time requirements for 7-week semesters or 5-week summer courses). The actual amount of time required will, of course, vary from one person to another. It is absolutely essential that you do not fall behind.

Although this is an asynchronous course, this is not an individually paced course. Access to course materials, assigned discussions, assignments, exams, and the like will follow a schedule spread out over the semester (similar to a class in the traditional format). There will be set dates for exams and deadlines by which you must complete all unit assignments. You may, however, work *ahead* in the course. Deadlines for assignments are listed in the *Course Schedule*.

If you encounter any unforeseen circumstances (family emergency, jury duty, etc.) that greatly compromise your coursework, contact the instructor immediately. Alternatives for missed time may be arranged at the discretion of the instructor. Note: Vacation time does not count as an excused "absence". Please plan your vacations around assignment due dates or submit your assignments early.

GRADE REPLACEMENT/FORGIVENESS

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions that students need to be aware of. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- · Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- · Being reinstated or re-enrolled in classes after being dropped for non-payment
- · Completing the process for tuition exemptions or waivers through Financial Aid

STATE-MANDATED COURSE DROP POLICY

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
