#### **<u>Reading Assignments</u>:**

Reading assignments are indicated in the course syllabus. In order to benefit from the class, keep up with the pace of instruction and benefit from the Boshears observation experience, it is essential that you complete each reading assignment in a timely manner.

# <u>Quizzes</u>:

You will take a total of 5 mastery quizzes over chapters that you need to comprehend for a better understanding of this course. The quizzes will be taken in class and are multiple-choice, true/false and short answer. Dates for the chapters' quizzes are listed in your syllabus. Bonus quizzes are provided for extra points.

# **Disability Report & Class Presentation:**

A disability report of your choosing will be presented to the class using PowerPoints taken from research used to write your paper. Your report needs to include a brief history of the disability, diagnoses, treatment or cure for the disability plus any scientific explanation for the condition, gender specific documentation of facts or myths associated. You will need to provide an adaptive PE lesson that supports the disability. Your class presentation must be at least 15 minutes and students need to be dressed appropriately in business casual for your presentation. Reports will begin after spring break.

# **Boshears Observations and Paper:**

You are responsible for logging 20 hours of observation, 10 for therapeutic horseback and 10 hours in adapted physical education class. Signage sheets from teachers at Boshears, McDaniel & White must be signed each time you observe at Boshears, In addition, the time log from the education department must also be signed each time you are at Boshears. You will then write a paper (minimum of 3 pages) based on your notes, personal experiences and participation during the 20 hours. This is a major portion of your grade for the course and it is most important that you complete your hours in a timely manner and follow the criteria that is given for writing this paper.

## Grades:

Grades will be continually available via the gradebook as will your class attendance. It is your responsibility to monitor and ensure that your grade is correctly recorded. The final course criteria for grades are listed in your syllabus. There will be no grace period given for due dates on papers, mid-terms or finals. Your final course grade is reflected by the number of points you earn throughout the course. Assignments are counted late one week after due date and receive 20% off. After one week a 0 is recorded for your grade. except with prior discussion with the instructor.

Although we live in a world in which technology is a necessity, I am respectfully asking that you keep your cell phones put away during lecture times. We will have breaks during class time in which you can check or send messages. This is an expectation of common courtesy and will be very much appreciated.

# Grade Replacement/Forgiveness and Census Date Policies – January 28, 2019

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <u>http://www.uttyler.edu/registrar</u>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions that students need to be aware of. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

# **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
