Student Learning Outcomes: At the completion of this course the student will be:

- 1. Able to identify/discuss the major concepts related to information processing, attention, motor programs, neural mechanisms, and constraints of motor control.
- 3. Able to apply basic motor learning principles to everyday life and activities.
- 4. Able to illustrate and explain the different stages of skill acquisition.
- 5. Able to discuss and give examples of the different learning styles.
- 6. Able to outline/explain the methods used for developing and implementing a motor learning research project.
- 7. Able to incorporate technology to orally present research related to the field.
- 8. Able to effectively collaborate with others to accomplish assigned tasks.

Methods of Instruction: CANVAS

Student learning experiences to include but not limited to: a) lectures with related PowerPoint slides, b) demonstrations, c) problem solving situations and laboratory experiences individually and in groups, d) observation and analysis of motor learning and performance, e) reading designated textbook and supplementary material upon assignment, e) online engagement through quizzes and discussion board.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog.
