Course Description

Study of principles and processes involved in learning and teaching motor skills, and the theories of control of movement. Application is made to sport, ergonomics, and rehabilitation.

Co-requisite: KINE 3132 (Lab)

Student Learning Objectives: After completion of this course the student will be:

1. Able to identify/discuss the major concepts related to information processing, attention, motor programs, neural mechanisms, and constraints of motor control.

- 2. Able to apply basic motor learning principles to everyday life and activities.
- 3. Able to illustrate and explain the different stages of skill acquisition.
- 4. Able to discuss and give examples of the different learning styles.

5. Able to outline/explain the methods used for developing and implementing a motor learning research project.

- 6. Able to incorporate technology to orally present research related to the field.
- 7. Able to effectively collaborate with others to accomplish assigned tasks.

Please do not email the instructor assignments and/or projects unless otherwise asked to. A missed exam without a prior excuse receives an automatic zero.

Participation: Students are strongly encouraged to ask, and respond to, questions in class; this student/instructor interaction makes for a more interesting class overall, and facilitates better learning. You may (and are encouraged to) work in groups to complete all homework and assignments. However, the work that you hand in is expected to be original and to be your own. <u>Any</u> act of cheating or plagiarism will result in a grade of zero for that assignment. (This means *put everything in your own words*!) Depending on the extent, any incidence of cheating or plagiarism may result in dismissal from the course, and further discipline by the university.

<u>*Tech:*</u> It is expected that each student is proficient in the use of Microsoft Office (Word, PowerPoint, Excel) or Apple iWork (Pages, Keynote, Numbers). You will be required to use these applications extensively in this class. If you do not know how to use these applications, seek help from Computer Services or similar assistance. All written work must be legible.

GRADE REPLACEMENT/FORGIVENESS AND CENSUS DATE POLICIES

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Spring, the Census Date is January 29.) Grade Replacement Contracts are available in the Enrollment Services Center or at <u>http://www.uttyler.edu/registrar</u>.Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (January 29th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

• Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.

- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

STATE-MANDATED COURSE DROP POLICY

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- 6. collaborating with or seeking aid from another student during a test or other assignment without authority;
- 7. discussing the contents of an examination with another student who will take the examination;
- 8. divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
- 9. substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
- 10. paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
- 11. falsifying research data, laboratory reports, and/or other academic work offered for credit;
- 12. taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
