This COURSE OF STUDY involves all aspects of trombone performance. Emphasis is placed on playing fundamentals such as breathing, embouchure, articulation, tone, technique, rhythm, phrasing, etc.; the establishment of a good warm-up procedure/daily routine and practice habits; the regular practice of technical studies and scales; the use of the F valve; and introduction to various clefs commonly used in trombone literature. Study material includes standard textbooks, etude collections, transcribed and original solos for trombone, excerpts from the orchestral and wind band literature, and other material suited to the needs of the student.

STUDENT OBJECTIVES are: 1) to develop a daily practice routine which will lead to the development and maintenance of technical skills requisite for a high standard of artistic self expression, 2) to develop an understanding of fundamental tools of phrasing and artistic expression, 3) to develop the ability to sight read with fluency, 4) to become familiar with a cross section of the standard teaching and performance literature available for the trombone, 5) to develop a strong concept of good sound and tone, 6) to develop a strong concept of rhythm and time, 7) to develop a clear understanding of fundamental pedagogical philosophies and practices, 8) to develop comfort and ease with the methods and phases of preparation leading to successful solo performances, 9) and to become familiar with the major professional players of trombone in the world today and in history.

PREPARATION TIME: In order to get the most from this course and to develop a moderate level of skill and musicianship, it is strongly suggested that a minimum of two hours *per day* be devoted to preparation of the assigned material. Students wishing to reach the highest levels of skill and musicianship should devote much more time and energy to the study of this course material.

REQUIRED MATERIALS:

Instrument – appropriate for the study and performance of trombone literature.

Metronome – suggest Boss Dr. Beat (various models available) or an appropriate phone app such as *Tonal Energy*.

Chromatic Tuner – suggest Boss model TU-12H or similar needle-meter model or the *Tonal Energy* phone app.

Fixed-pitch tone generator – Boss Dr. Beat or the *Tonal Energy* phone app.

ASSESSMENT and GRADES will be based on many *aspects* of performance during the semester. These aspects include: attendance, weekly preparation, scale exams, periodic etude exams, recital performances, and juries (final exam). *Criteria* to be considered in determining grades are:

- 1) the *quality* of the work presented in performance either in lesson, master class, recital, or jury;
- 2) the attention given to *practice techniques* as suggested by the instructor, and
- 3) the level of *improvement* accomplished on a given assignment.

The various aspects, along with the percentage portion of the semester grade, are briefly explained as follows:

Attendance: It is expected that students be present for all scheduled lessons. Instruction cannot take place unless the student and teacher meet on a regular basis. If a student has a legitimate reason for missing a lesson or if the instructor misses a lesson, the instructor will make every reasonable effort to make-up the lesson. Each lesson missed without an acceptable reason will lower the semester grade by **10%**.

Weekly Preparation: This grade will be based on the week's preparation of material assigned the previous week and/or material that is considered to be 'in progress,' such as solos or technical studies, that have been assigned previously. Weekly preparation also includes the student's efforts to obtain required material and response to communication from the instructor. **50%**

Scale Exams: Consists of the performance by memory of a predetermined scale, set of scales, or scale pattern(s) in any key and at a prescribed tempo. To aid in student planning, the scale patterns or sets will be determined at the beginning of each semester and will change from semester to semester. Any exam may be made-up or repeated only at the discretion of the instructor.

(Part of Weekly Preparation)

Etude Exams: Etudes will be assigned and studied on a regular basis during the semester. Each etude will be assigned a date of completion at which time it will be assigned a grade for the work done on it. The assignment may include a special aspect of performance such as memory or transposition at sight or have special emphasis on certain performance criteria, as the instructor deems appropriate. (Part of Weekly Preparation)

Recital Performance: According to departmental policy each student must perform once each semester on a recital with accompaniment (when appropriate). The performance selection will consist of a major original or transcribed solo (or portion of a solo) for the major instrument. The recital will be near the end of the semester and the performance will be in front of an audience of UTT faculty, student peers, and miscellaneous guests. **25%**

Juries are effectively the *final exam* for applied lessons. This performance will consist of a major original or transcribed solo (or portion of a solo) for the major instrument (an effort is made to not repeat the selection(s) performed in the Recital Performance). The performance will be graded by a *jury* of select members of the Applied Faculty in the Department of Music. The jury grade will be an average of the grades given by each of the jurors. **25%** (*The date(s) of Juries are TBD.*)

Reading Assignments and Special Projects: Each semester the instructor *may* assign a student a special project to be completed at some predetermined time during the semester. This project may include study-exams on required textbooks or periodical articles, or research on a particular aspect of performance. With the approval of the instructor students will be allowed to design their own special projects for extra credit. One special project will be allowed per semester.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
