Course Description

Applied voice is the study of singing from the standpoints of technique, literature, and performance. Principles of vocal technique based on established vocal pedagogy will be studied alongside literature appropriate for the developmental level of the student. Basic singing technique is explored for instrumental music education majors and non-music majors.

Objectives of This Course:

As a result of voice study, the student will be able to a) perform memorized a minimum two songs and b) demonstrate appropriate and improving competencies listed below.

Musical Learning & Skills

- Identify and develop productive practice techniques and preparation skills
- Develops a capacity for expressive and healthy singing
- Develops a vocal technique in the areas of posture, breathing, phonation, resonance, and articulation

- Sings repertoire that is vocally and age-appropriate
- Demonstrates good diction in different languages
- Performs the assigned literature from memory
- Develops and implements research skills for singing

Attitude and Cooperation

- Prepares adequately for performance
- Displays confidence and relative ease in performing
- Presents a professional attitude toward performing including promptness and appropriate dress
- Develops performance skills to include stage etiquette, stage presentation, and vocalism

Course Activities and Policies

1. Students will sing individually in front of peers in this class. Please be prepared to sing in every class meeting.
2. **Two exams:** there will be two major exams to evaluate the knowledge of the vocal pedagogy.
 - 1st Exam: **February 22nd** during the class time on zoom
 - 2nd Exam: **April 12th** during the class time on zoom
3. **Two performances:** students will perform a song for SPA Facebook live stream performance as part of their midterm grade. The final performance will be a video recording submission of a song. Failure to perform in the recital will lower a letter grade of the final semester grade.
 - 1st Performance: **February 15th** at 6pm in the Braithwaite Recital Hall
 - 2nd Performance: Submission of a video recording on YouTube by **April 18th** midnight
4. Please dress in a professional attire for performances.
5. All sheet music must be printed and filed in a 3-hole binder.
6. All performances will be by memory. Performance with music will lower a letter grade.
7. **Performance Observation:** Each student is required to write 300-word observation of UT Tyler Vocal Workshop on **February 6 (10am-12pm and 1-3pm)**.
8. **Presentation:** students will show their binders and report in the class what they learn. **April 14th (Wednesday):** Presentation of their binder and learning
9. **Attendance:** Students are expected to attend every class. Only three absences are allowed to be able to pass the course. Please inform the professor prior to any excused absence. Exams and performances will not be made up unless approved by the professor in advance. Three tardies will count as an absence.

Grade Description

A	The student has excelled in all areas of study. He or she performs exceptionally well in studio class and in juries, incorporating all elements of voice study that have been a focus during voice lessons. He or she has thoroughly maintained a portfolio to the printed standard and has shown development in his or her artistic sensibility throughout the semester by meeting the short- and long-term goals. His or her attendance was unblemished.
B	The student met most of the short- and long-term goals established at the beginning of the semester and prepared the appropriate number of songs for juries. His or her portfolio was mostly complete, but lacked a sense of artistic growth throughout the semester. The student's attendance was good, but not ideal.
C	The student met few of the goals agreed upon at the beginning of the semester. He or she did not prepare the required number of pieces for juries. He or she was missing large portions of the portfolio, and its completion was haphazard. Attendance was far below average.
D	The student performed poorly in all three subjects and did not demonstrate interest or initiative to improve throughout the semester.
F	The student failed to meet any of the teacher's expectations of progress, effort, or attendance.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is August 31.) Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (September 10th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions or exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;

using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;

collaborating with or seeking aid from another student during a test or other assignment without authority;

discussing the contents of an examination with another student who will take the examination; divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructor has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;

substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;

paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;

falsifying research data, laboratory reports, and/or other academic work offered for credit; taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student

knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and

misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.

ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.

iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.

iv. All written work that is submitted will be subject to review by plagiarism software.
