Course Description: A survey of music technology, along with a practical introduction to contemporary music hardware and software applications.

Prerequisite: None.

Course Learning Objectives: Upon successful completion of this course, students will be able to:

- Demonstrate an understanding of the fundamental properties of **sound** in both physical and digital media.
- Demonstrate knowledge of and working proficiency with the basic properties of digital **audio**.
- Demonstrate knowledge of and working proficiency with the basic properties of **MIDI** and software instruments.
- Demonstrate knowledge of and working proficiency with the basic functions of music **notation** software.
- Demonstrate basic knowledge of music hardware/software technologies and how they function in a signal flow.

Methods for Assessing Outcomes: Outcomes will be assessed through a variety of daily assignments, quizzes, and mini-projects; four major Section Projects; and a Final Project in which students will create, edit, and distribute a collaborative class album, accompanied by a publicly-accessible online digital music portfolio.

Methods of Instruction: Course content will be split between a traditional classroom lecture format, and independent time working in the Piano Lab and Electronic Music Studio rooms for demonstrations of and hands-on individual practice using various hardware and software, divided as follows:

- Monday: Show-and-tell, collaborative work, and preview lecture time (attendance required)
- Wednesdays: Lecture day (attendance required)
- Fridays: Independent Lab Work time, with instructor supervision as needed (attendance optional – see below)

**** Attendance Policy:** Attendance is treated differently in this course than in most. This semester consists of 42 class days, 14 of which are *optional attendance* Independent Lab Work Fridays. On these Lab Days, you are encouraged to be present in the Piano Lab or Electronic Music Studio to work on Section Projects or other assignments, with the instructor there to guide you. Attendance will not be taken on Fridays only, as this is your independent work time. However, on the class day immediately following each Friday (usually a Monday), each student must present to the class on any progress and roadblocks he/she has encountered since the previous Wednesday. Insufficient evidence of effort and progress in the course will count as a tardy or unexcused absence for that previous Friday, at the discretion of the instructor.

On all other class days (Mondays and Wednesdays), full attendance and participation are expected. Arrival after class has begun will count as a tardy. Three tardies will count as one unexcused absence.

For this course, students are allowed **three (3) “free” unexcused absences**. After this, the following penalties may be applied:

4-6 unexcused absences = 1 letter grade reduction

7-9 unexcused absences = 2 letter grades reduction

10+ unexcused absences = automatic failure of the course (“F”)

(This penalty is not part of the Participation grade, which reflects engaged activity in class.)

Additionally, avoidable distractions such as cell phone use/texting, eating food, outside work, and unnecessarily leaving the room during class time may result in a tardy or absence for the day, at the instructor’s discretion. Multiple occurrences will result in the student being asked to leave the class session.

**** Due Dates and Absences Policy:** All assignments are due on the days indicated, at the start of class. Absolutely no credit will be given for assignments, quizzes, or projects that are late or missing due to *unexcused* absences. This applies to all work, from in-class quizzes or daily assignments to major Section Projects and the Final Project. At the instructor's discretion, absences may be considered *excused* only for legitimate, *documented* reasons (serious illness, family emergency, etc.). Even in cases of *excused absences*, any outstanding assignments are due at the following class period. Missed quizzes typically must be made up within one week of the absence. In all cases, it is the student’s responsibility to inform the instructor of absences as soon as possible, and to *document* that absence if an *excused absence* is being requested.

Academic Integrity: Academic dishonesty (cheating, copying homework, plagiarism, etc.) will not be tolerated in any form. All occurrences of academic dishonesty will be reported to the administration. Consequences may lead to failure of the assignment/exam, failure of the entire course, and/or expulsion from the university.

Grade Replacement/Forgiveness and Census Date Policies: Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept. 11th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy: Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
- using, buying, stealing, transporting, or soliciting in whole or in part the contents of an unadministered test, test key, homework solution, or computer program;
- collaborating with or seeking aid from another student during a test or other assignment without authority;
- discussing the contents of an examination with another student who will take the examination;
- divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructor has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
- substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
- paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
- falsifying research data, laboratory reports, and/or other academic work offered for credit;
- taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and

iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any
