#### **COURSE DESCRIPTION:**

This course explores the reciprocity between health care policies and population health.

Expanded version: This course explores the reciprocity between health care policies and population health, and emphasizes the relationship of behaviors as well as social and political structures to health outcomes. A variety of theories, concepts, and models from a range of social and behavioral disciplines will be utilized to examine influences at multiple levels (e.g., personal, community, institutional, and public policy).

Prerequisites: Admission to MSN program or CI.

**Credit Hours:** 3 SCH

#### **Student Learning Outcomes**

Upon successful completion of this course, the students will have the opportunity to:

- 1. Identify causes of social, political, and behavioral factors that affect health of individuals and populations.
- 2. Identify individual, organizational and community concerns, assets, resources and deficits for social and behavioral science interventions.
- 3. Examine the processes involved in development and implementation of institutional, local, state, and federal policies that impact health care.
- 4. Identify critical stakeholders for the planning, implementation, and evaluation of public health programs, policies and interventions.
- 5. Apply ethical principles to the analysis of a health policy.
- 6. Describe steps and procedures for the planning, implementation, and evaluation of a health promotion program, policies and interventions.

Course assignments are due per the course calendar. No extensions are given without prior faculty approval. **There is a 5 point/day penalty for late assignments.** 

It is considered academic dishonesty to copy and/or print quizzes or exams or to discuss them with prior, current, or future students. It is encouraged to keep track of your responses to items noting the item # and response choice on a piece of paper so if you are disconnected and access is reset you can quickly insert the answers without having to re-read each item again. Please throw the answers away once you have completed the quiz

Writing Assignments: Turnitin is a feature provided by Canvas that is designed to detect plagiarism or non-original student work. Your instructor may set up this feature so that when you submit papers, they are automatically sent through Turnitin. The program checks your work against a comprehensive database of source material including previous students' work and other papers and materials found on the web. An originality report will be generated that indicates the percentage of non-original material (text that matches existing sources) found in your paper. The purpose of using Turnitin in your course is to ensure you are writing original papers and to encourage you and all students to properly attribute all sources used.

**Discussion Board Postings:** Throughout the semester you will participate in group discussions to help you become familiar with concepts related to health policy and population health. Topics vary and are introduced within corresponding modules. Discussion board guidelines and the grading criteria can be found in the course syllabus.

The purpose of the discussion board in an online graduate program is to take the place of the class interchange that would occur in a face-to-face class. It is your opportunity to demonstrate your mastery of the assigned readings and your ability to supplement those readings with expanded exposure to related (and sometimes contrary) information that you will seek as you begin to understand and be informed. So, we will expect you to share ideas you have gained from the literature, noting the source when appropriate and interpreting into your own words. We will also expect that you will use a more complex thought process to dissect and analyze what you read in the literature and in the discussion thoughts of your fellow students as you offer your own insights. The following includes guidelines and allow you to see thinking process we will use to assign a grade to the discussion board exercises.

- Each participant is responsible for participating in the asynchronous discussions of each assignment. This participation will include posting answers to questions posed by the instructor and / or replying to other participants' postings.
- Postings must be timely. Deadlines are listed in the Weekly Content Calendar. Please note that all discussion postings must be completed by 11:59 PM Central Standard Time on the due date.
- Participants should plan on entering the Discussion area at least three times to read and comment on other postings. Posting answers to the questions posed in the Discussion area should be done in advance of the deadline to allow other participants the opportunity to comment.
- Quality of answers is as important as quantity. A participant's comments should add to the discussion. Comments should be supported with references cited appropriately. The instructor and/or participants may use synchronous chats as the need arises.
- APA format is expected including grammar, spelling, and punctuation.

Note: When posting to the discussion area, please type in your comments directly into the discussion. Do not type your comments into a document and then attach it to the discussion-this method is difficult for some students to access. You may type your comments into a Word document, then copy and paste it into the Discussion Board.

# **Reading Assignments**

- Assigned readings in graduate education are the beginning, not the endpoint. These
  readings will point you in the direction of continued reading and pondering of your
  scholarly thoughts. Each participant is responsible for completing the reading
  assignments in a timely manner. Deadlines are listed in the Course Schedule.
- Discussion and written assignments are made with the assumption that required reading assignments are completed prior to completion of discussion and written assignments.

#### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Spring, the Census Date is January 29.) Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (**January 29**) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

# **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another

2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
