Process

NOTE: STEM OPTs ending before October 2016 are not eligible for an additional seven months. There must be at least 150 days between your STEM OPT end date and the date USCIS receives your application AND that date must fall between May 10 and Aug 8.

1. Print from www.uscis.gov
 - a. **G-1145** (optional-email/text notification)
 - b. **I-765**
 - c. **I-983 Training Plan** (For instructions and a video tutorial how to complete this form, go to: <https://studyinthestates.dhs.gov/stem-opt-hub>)

For I-765, #3, use your address OR ISSFS address (*We will email you as items arrive.*)

2. Print from http://www.uttyler.edu/oip/forms_library.php
 - a. **OPT Extension I-20 Request Form**
3. Submit to ISSFS:
 - a. OPT Extension I-20 Request Form
 - b. Copy of completed I-765
 - c. Copy of completed Form I-983 Training Plan
4. The advisor will review all materials and create an OPT Extension I-20. **Allow 5 business days for your materials to be reviewed and an I-20 to be issued.**
5. Collect OPT STEM I-20, sign and date. Keep the original, **include a copy** in your application.
6. Assemble package and **mail** to USCIS. Applications must be received at USCIS between May 10 and August 8 to be considered and the I-20 must be less than 60 days old (from print date).

If USCIS receives the application before end of the STEM OPT, **the work authorization continues** automatically while the application is processed, up to 180 days.

- _____ Copy of STEM OPT EAD card
- _____ Copy of passport ID page (showing expiration date)
- _____ Copy of U.S. visa
- _____ Copy of I-94 from CBP website (If you have white card I-94, copy front and back)
- _____ Copies of all previous I-20s
