STEM OPT Extension Application Procedure

- 1. Obtain and fill out the following USCIS forms:
 - a. <u>I-765</u> (For related resources, see https://www.uscis.gov/i-765)
 - b. G-1145 (Optional-for email/text alerts from USCIS re. OPT app status; also via uscis.gov/i-765)
 - c. I-983 "Training Plan" (For form completion guidance visit https://studyinthestates.dhs.gov/stem-opt-hub)

- 2. Download and fill out the <u>STEM OPT Extension I-20 Request</u> form
- 3. Pay the \$100 OPT administrative fee through myUTTyler.or in person at the Cashier's counter in the UC.
- 4. Email to oip@uttyler.edu:
 - a. Stem OPT Request Form
 - b. Form I-765
 - c. Form I-983 Training Plan
- 5. The advisor will review your materials and create a STEM OPT I-20.
- 6. You will be emailed a scan of the I-20 that can be used for the application. The original I-20 will be mailed to you unless you make other arrangements.
- 7. Assemble package and mail to USCIS within 60 days of the I-20 print date. (Late applications are denied.)

If the STEM OPT application is received by USCIS before the OPT end date on your EAD, the initial OPT work authorization continues automatically up to 180 days while the application is processed.
