PHAR 7145: Pharmacy Law Spring Semester 2022

Course Description

This course focuses on the application of Federal and Texas Pharmacy Law and expands on the rules and regulations established by the Texas State Board of Pharmacy essential for practicing pharmacy legally at the state and federal level.

Additional Course Information

This course introduces the student to various Federal and Texas Pharmacy Law concepts and how those translate from classroom application to the real-world setting. During the semester we will explore the different classes of pharmacy, the Federal and Texas Controlled Substance Acts, the Texas Dangerous Drug Act, the Texas Pharmacy Act, patient complaints, pharmacy inspections, disciplinary actions and penalties, and compounding regulations.

The student's faculty advisor may receive an academic alert to act upon on the student's behalf.

All examinations, tests, and assignments, including the final examination, may be **cumulative**. Students are responsible for material presented during the prior courses.
