#### **SYLLABUS**

In 1945, Western Europe laid in ruins, the collective action of more than four years of total war. The international political hegemony of Europe had been shattered, and the new superpowers, the United States and the Soviet Union, had supplanted Europe as models of political and economic development. In 1945, few observers would have predicted that within less than two decades Europe would find a new way to industrial prosperity and political stability. Yet, Western Europe did experience a remarkable phase of economic and political resurgence, characterized by industrial growth, collective affluence, and effective parliamentary governance.

Today, many Western European nations enjoy higher per capita standards than the United States. How are we to explain the success of post-war Western Europe? What does the future hold for such an economically, politically, and culturally diverse continent?

Will Europe unite in the twenty-first century, or will a new hegemon arrive to dominate the continent? This course seeks to explore these and other questions by providing the student with a thorough analysis of the historical, political, and economic situation in Western Europe.

#### **Learning Outcomes:**

After successfully completing this course, students should be able to demonstrate:

- familiarity with terminology used to study Political Science and Comparative Politics
- basic knowledge of a variety of histories, cultures, and ideologies and their impact on current European societies
- an understanding of major governmental and economic structures throughout Europe
- comprehension of the interrelationships of domestic policies and international events

### **Course Requirements:**

#### Exams:

#### **Research Paper:**

3. Successful completion of a 3–5-page research paper with the topic to be discussed in the introductory section on Canvas. The paper will be due on November 19, 2021, and has to be uploaded through Canvas.

#### **Grading Policy:**

Each exam, including the final, will be worth 100 points. The exams will consist of essay questions and short identifications. The report is worth an additional 100 points and will be discussed in the introductory section on Canvas. The grading scale will be the following:

#### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. (Links to an external site.) Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No
- Receiving 100% refunds for partial (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for nonpayment
- Completing the process for tuition exemptions or waivers

### **Financial Aid State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- collaborating with or seeking aid from another student during a test or other assignment without authority;
- discussing the contents of an examination with another student who will take the examination;
