#### **COURSE OBJECTIVES:**

Analyzing Seven Pillars of Servant Leadership to evolve and implement the competencies and behaviors of servant leadership.

- ➤ Complete reflections on servant leadership from successful servant leaders in the local community (Analyzing interviews on Servant Leadership). This exercise aims for participants to know about the real leaders who serve others and who change lives in the local area.
- ➤ Learn about critical traits, priorities, practices, and principles that help servant-leaders succeed to achieve great relationships and results.
- ➤ Learn about the cause of mental health issues from COVID 19 in healthcare workers, ways to cope with stress, and dealing with symptoms of mental illnesses.
- > 8 Trends driving business growth and success in the new economy
- Explain the importance of Crisis Management planning, proactive and effective responses to a crisis.
- Develop functional Crisis Management plans to avoid crises and minimize the impact of a crisis.
- ➤ Identify crisis and apply Crisis Management methods for diagnosing and resolving it.
- ➤ Implement organizational changes based on how internal and external factors and their effect on the crisis' severity, duration, and impact.
- ➤ Outline 4 major stages of Crisis Management framework, and the actions taken at each stage.
- Apply the strategic management process from a corporate and business level.

A variety of methods will be used to help the student master the material, including recorded lectures, PowerPoints, videos, and homework assignments.

# **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Cen-sus Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.

Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)

Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)

Being reinstated or re-enrolled in classes after being dropped for non-payment

Completing the process for tuition exemptions or waivers through Financial Aid

## **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog.
