### **Course Description**

This course will cover aerial photogrammetry and remote sensing.

The primary focus of this course is to prepare future land surveyors for the Surveyor in Training (SIT) exam and professional practice as a land surveyor.

#### **Course Objectives**

Provide students with basic knowledge of photogrammetry including, but not limited to:

- 1. the history of aerial photogrammetry, the camera, optics of the photogrammetry camera, orthophotos, relief displacement, fundamentals of mission planning and execution, flight heights, and scales.
- 2. Provide students with an understanding of remote sensing and its relation to photogrammetry and geodesy.

Essay. Each student must complete an essay this semester. The essay must be a minimum length of 3 pages double spaced. Page length does not include optional cover page or the works cited page. The essay may cover any Photogrammetry topic. The essay must be double spaced with 1-inch margins and have Times New Romans 12 point font. Paragraphs should have between 4 and 8 sentences, and the sentences should be complete. Essay due date is provided in the course schedule found below. The essay will be graded subject to the following penalties. Penalties will be assessed off the top of the allowed grade before any other grading is tallied. If all three of the penalties are assessed, the paper will receive a grade of zero. Credit will only be given for writings of the student. Copying the work of others will not be tolerated, and the grade will be adjusted accordingly.

- 1. 20% penalty if any paragraph contains more than 10 sentences.
- 2. 20-100% penalty for any essay shorter than 3 pages.
- 3. 100% penalty if the essay is not a topic relating to the topics of this course.
- 4. 40-100% penalty for any essay that has more than a 20% similarity score.

The essay shall include the following information at the top of the first page unless a cover page is used:

First & Last name of student Course Name and Number Date

Possible topics include, but are not limited to:

- 1. Drones (as they relate to surveying)
- 2. The future of surveying remote sensing using drones
- 3. Aerial photogrammetry v. drones
- 4. LiDAR
- 5. Changes in Digital Photogrammetry v. Analog Photogrammetry (film)

#### **Course Policies:**

Content for examinations will be taken from lectures, demonstrations, reading assignments, laboratory exercises and any audio-visual materials used, i.e. films, tapes, slides, etc.

Make up examinations are the student's responsibility. No excuses will be accepted after the exam is given. The instructor must be notified **prior** to the scheduled exam. If not, the student forfeits his/her right to take the exam. Quizzes will not be made up unless a **prior** acceptable excuse for an absence has been received by the instructor.

#### Attendance:

Attendance is mandatory and will be taken at every scheduled class and laboratory period. No make-ups unless:

- 1. Organized university trip.
- 2. Illness or death in **immediate** family (mother, father, brother and/or sister).
- 3. Illness of student.

Each one of these will require either a **doctor's statement** or a **signed** statement from the individual in charge of the trip.

A student will lose a letter grade in the course each time s/he is absent or late 3 times. Any student entering the classroom 1 second after the scheduled starting time will be considered late unless accompanied with a valid excuse.

#### **Late Work:**

All work not turned in on time will have an automatic reduction in value to 50% of its full value. **Work that is not turned in by the next class will NOT be accepted.** Exceptions to this will be as per University Policy concerning absences from class.

If you know an assignment will be late for a valid reason, inform your instructor in advance to avoid unnecessary penalty.

### **Format for Reports:**

Each laboratory report will be placed in a folder, arranged in such that the reader can easily examine the contents. Any materials that are hard to read or require special handling to get at will not be graded. The cover must contain the following:

- 2. Prepared by: Your Name Here
- 3. Submitted to Dr. Mark Miller in partial fulfillment of the course
- 4. Course Name, TECH 4323 Lean Production
- 5. The Date

Your grade will reflect the quality of the presentation.

#### **Cell Phones:**

Cell phones are to be seen and not heard. Make sure you turn off your cell phone during class or turn it to the vibrator mode. A ringing cell phone is a distraction and is inappropriate for the classroom. Allowing your cell phone to ring and then answering it is very rude. It is not fair to your fellow classmates who have paid for this course. Please be considerate and make sure your cell phone is turned off during any of your classes. Students will be asked to leave for the day if this behavior continues.

#### Discrimination:

The policy of this department is to make your college experience as pleasant as possible. While the instructor is talking, it is understood that no one should be talking. Students talking in class prevent other students from hearing the instructor and learning the material that is required to pass the course. If you are caught talking then you will earn a zero on your daily quiz grade. On the second offense, you will be asked to leave. This behavior is rude and disruptive and most students who talk in class typically earn lower grades. It should be noted, that students

who have been granted permission to talk by the instructor should not be interrupted as well.

### Offensive Language:

Any type of offensive language will not be tolerated in the classroom or laboratory. How you speak to your friends outside the classroom is your business, however, when you are in the classroom you must follow the University of Texas rules of conduct. You will be asked to leave if your language or conduct is offensive.

#### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

# **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
