### **Course Description**

An introduction to engineering graphics techniques using computer aided drafting software. This course will cover specialized CAD techniques in lines, arcs, editing, and dimensioning. Also included will be geometric construction, three-view drawing, sectioning, and basic 3-D drawing.

### **Course Objectives**

This course will give students the ability to create various engineering drawings by using AutoCAD 2020 computer software. Specifically, students will be able to:

- 1. Differentiate between orthographic and pictorial drawings
- 2. Draw Multiview drawings
- 3. Understand how to read blueprints
- 4. Recognize the significance of engineering drawings
- 5. Use the functionality of the AutoCAD 2020 software application

### **Student Learning Outcomes**

- Demonstrate a comprehensive knowledge of engineering graphics by earning passing scores of 70% or higher on quizzes and exams.
- 2. Sketch two-dimensional orthographic drawings and three-dimensional isometric views.
- Create and modify two-dimensional orthographic drawings using AutoCAD 2020 software, complete with construction lines, dimensions, and layers, conforming to industry standards.
- 4. Create three-dimensional solid models using AutoCAD 2020 software.
- 5. Define drafting nomenclature by successfully passing guizzes and exams.

6. Demonstrate how to use the AutoCAD 2020 software application tools, techniques, and skills by successfully completing assignments and homeworks.

### **Core Competencies**

- Computer-Based Skills the student will complete written assignments using the word processor and AutoCAD 2020 software. The student will complete drawing assignments using AutoCAD 2020.
- 2. Communication Skills the student will exhibit a mastery of both written and oral skills in completion and presentation of the assigned projects.
- 3. Interpersonal Skills the student will interact in class discussion regarding engineering graphics.
- 4. Problem Solving (Critical Thinking) the student will use conceptual thinking to analyze and make decisions based on knowledge and facts regarding engineering graphics.
- 5. Ethical Issues in Decision Making and Behavior the student will gain an appreciation of the ethics of engineering graphics through examination of various processes.
- 6. Personal Accountability for Achievement the student will complete the projects at the time designated by the instructor.
- 7. Competence in Engineering Graphics
  - a. Understand the importance of applying these methodologies and tools in the use of AutoCAD 2020 software and in the creation of engineering drawings.
  - b. Identify and analyze factors for successful engineering drawings, as well as reasons for errors in engineering drawings.
  - c. Students will discuss from their perspective engineering drawings and facts from their own life experiences.

### **Course Policies:**

Content for examinations will be taken from lectures, demonstrations, reading assignments, laboratory exercises and any audio-visual materials used, i.e. films, tapes, slides, etc.

Make up examinations are the student's responsibility. No excuses will be accepted after the exam is given. The instructor must be notified **prior** to the scheduled exam. If not, the student forfeits his/her right to take the exam.

Quizzes will not be made up unless a **prior** acceptable excuse for an absence has been received by the instructor.

### **Attendance:**

Attendance is mandatory and will be taken at every scheduled class period. No make-ups unless:

- 1. Organized university trip.
- 2. Illness or death in **immediate** family (mother, father, brother and/or sister).
- 3. Illness of student.

Each one of these will require either a **doctor's statement** or a **signed** statement from the individual in charge of the trip.

A student will lose a letter grade in the course each time s/he is absent or late 3 times. Any student entering the classroom 1 second after the scheduled starting time will be considered late unless accompanied with a valid excuse.

### **Late Work:**

All work not turned in on time will have an automatic reduction in value to 50% of its full value. Work that is not turned in by the next class will NOT be accepted. Exceptions to this will be as per University Policy concerning absences from class. If you know an assignment will be late for a valid reason, inform your instructor in advance to avoid unnecessary penalty.

Each project report or homework assignment will be loaded onto Canvas. Do **NOT** email project reports or homework assignments to the instructor.

Your grade will reflect the quality of the presentation.

### **Discrimination:**

### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 2, 2022) Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets

published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept. 2, 2022) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

### **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
