Texas Legislative Session Overview

- Session Timeline: Convened: January 14, Adjourned: June 2
 - Texas Legislature meets biennially for 140 days.
- Texas Senate Composition: 31 members: 11 Democrats, 20 Republicans
 - Presided over by the Lieutenant Governor (non-voting), who also appoints all committee members.
 - 16 standing committees.
- Texas House of Representatives: 150 members: 62 Democrats, 88 Republicans
 - Speaker of the House elected by members: Dustin Burrows (West Texas/Lubbock)
 - Major rules overhaul: Created 30 standing committees and 12 permanent subcommittees.
 - No Democratic committee chairs for the first time in modern history.

Legislative Outcomes

- Bill Volume: Nearly 8,700 bills filed; approximately 14% passed (86% failure rate).
 - Legislative system is intentionally structured to be selective and rigorous.
- State Budget: Constitutionally required to pass a balanced budget.

- Budget covers: September 1, 2025 August 31, 2027.
- Major allocations: \$1 billion for school choice. \$33 billion to higher education institutions. \$82 billion for Medicaid (anticipated enrollment increase).
- A surplus existed at the start of the session; not all forecasted funds were spent.

Higher Education Legislation

- Senate Bill 37 Higher Ed Governance Reform: Alters faculty senate operations.
 - Reforms core curriculum review processes.
 - Establishes an Office of the Ombudsman (Governor-appointed, Senate-confirmed). Investigates complaints related to DEI (as restricted by SB 17), tenure, and faculty governance. Has authority to recommend withholding institutional funding for noncompliance.
- Remote Work Legislation: Two separate bills: One specific to institutions of higher education – highly prescriptive. One general for all state agencies – broader language.
 - Both still subject to potential veto by the Governor (veto deadline: June 22).
- Other Legislative Highlights:
 - Free Speech on Campus: Legislation passed.
 - Cybersecurity Measures: Significant activity around securing state systems; cyber command moved under DIR.
 - Research Security Bills: Focused on foreign threats and federal grant oversight.
 - DPRIT Act (Dementia Prevention Research): Modeled after Cancer Prevention Research Institute. \$3 billion investment pending voter approval on November 4, 2025. If passed, could bring significant funding to health campuses.

> Federal Update

- Department of Education: Conflicting signals: simultaneous efforts to dismantle and increase its responsibilities. Institutions are grappling with uncertainty and poor communication on mandates. Specific concerns raised about RSI (Regular and Substantive Interaction) and accessibility guidelines in online learning.
- Federal Grants: Litigation ongoing regarding indirect cost rate caps. Injunction obtained against the Department of Defense's proposed 15% rate cap.
 - UT System institutions are actively represented through associations filing suit.

Institutional Implications

- Faculty Senate vs. Staff Senate:
 - SB 37 impacts Faculty Senate only. Staff Senates are currently not affected.
 - Faculty Senate will undergo changes in structure, presidency, and senator appointments. Some existing practices already align with new legislative requirements.
- Program Evaluation:

- Legislation requires review of low-performing programs and alignment with workforce needs.
- Emphasis on value and return on investment for students.
